<b>Dual Enrollment (Grade 9 – 12)</b>	<p><b>Hifz Academy full-time tuition fees will be billed regardless of the number of classes in attendance at Hifz Academy or HCC/USF. Dual Enrollment is a privilege not a right.</b></p> <ul style="list-style-type: none"> <li>Students who do not receive a passing grade (minimum “C”) or are withdrawn from a course and are billed by the institution will be responsible for the charges and the amount will be billed to their parents’ tuition account.</li> <li>Students are expected to attain an “A” or “B” while dual enrolled.</li> </ul>		
<b>Payment Details</b>	<ul style="list-style-type: none"> <li>Our tuition is collected by FACTS Management.</li> <li>A <b>one-time non-refundable FACTS payment plan fee is charged to the family’s account of \$25.00</b> for annual mode/semi-annual or <b>\$55.00</b> for quarterly/monthly mode respectively.</li> <li>Tuition can be paid via FACTS from a credit/debit card (<b>2.85% fees apply</b>) or bank account (<b>no fee</b>).</li> <li>FACTS tuition payments will be due on July 5<sup>th</sup> for the new school year.</li> <li><b>Late fee of \$25.00</b> is assessed for payment made after the 10<sup>th</sup> of each month.</li> <li>A <b>return fee of \$30.00</b> is assessed by FACTS for payments returned by account holder.</li> <li>FLVS: Families who are on any scholarships (FTC, FES, AAA, HOPE, and Gardiner) will be billed separately for classes taken on FLVS.</li> <li>Any tuition or fees not covered by the scholarship will be billed to the parents.</li> </ul>		
<b>Withdrawal Policy</b>	<p><b>Withdrawal Policy after July 1, 2024:</b> Parents will be billed for the full months’ tuition if withdrawn after the 15<sup>th</sup> of the month and half months’ tuition if withdrawn on or before the 15<sup>th</sup> of the month for every month the student is enrolled at Hifz Academy. The same policy is applicable for any student receiving scholarship funding. The family is responsible to pay the remaining balance not covered by the scholarship, if applicable (Scholarship only pays for the days the student attends). <b>Please note that all families enrolled at Hifz Academy by and after July 1, 2024, will be subjected to the non-refundable fees paid during registration, regardless of whether the student is withdrawn before the first day of school.</b></p>		
<p><b>Non-Refundable Fees: Student Registration Fee (\$50 per student / \$150 per family of 3+), 50% of Development fee, plus \$100 towards Student Annual Fee will become due on July 15<sup>th</sup> of the new school year, or at registration, if registration occurs after July 15<sup>th</sup>.</b></p>
