Dual Enrollment (Grade 9 – 12)	<ul style="list-style-type: none">Tuition fees for full-time enrollment will be charged regardless of the number of classes the student attends at either Hifz Academy or HCC/USF.Dual enrollment is a privilege, not a guaranteed right.Academic Performance: Students are expected to achieve at least a "C" in each course. If a student does not meet this minimum grade or is withdrawn from a course, they will still be responsible for the associated fees. The fees for any courses in which the student receives a failing grade or is withdrawn will be billed to the parents’ tuition account.Students are expected to earn an "A" or "B" in their dual enrollment courses to maintain eligibility.		
Payment Details	<ul style="list-style-type: none">Tuition is billed for the full year, regardless of the students’ start date.Tuition payments are processed through a third party, “FACTS Management”.A one-time, non-refundable FACTS payment plan fee of \$55.00 will be charged to the family’s account.Payments can be paid via credit/debit card (with a 2.85% processing fee) or bank account (no fee).Tuition payments are due on July 5th for the upcoming school year.A \$25 late fee will be charged for payments made after the 10th of each month.A \$30.00 return fee will be assessed by FACTS for any return payments.Families using FES-EO/FES-UA/AAA may be billed separately for any FLVS (Florida Virtual School) classes taken.		
Withdrawal Policy	<ul style="list-style-type: none">If withdrawn after the 15th of the month: Parents will be billed for the full month’s tuition.If withdrawn on or before the 15th of the month: Parents will be billed for half of the month’s tuition.This policy applies to all students, including those receiving scholarship funding.Scholarship funds will only cover the days the student attends. Families are responsible for paying any remaining balance not covered by the scholarship.Any non-refundable fees paid during registration will not be refunded, even if the student withdraws before the first day of school. This applies to all families enrolled at Hifz Academy by or after July 1st.		
Non-Refundable Fees: Student Registration Fee \$50 per student or \$150 per family (for families of 3 or more students. 50% Campus Fee, plus \$100 towards Annual Fee. The first month’s tuition is also non-refundable if the student has not yet been approved for a scholarship. All non-refundable fees are due on July 5th of the new school year or at the time of registration if registration occurs after July 5th. Save \$50 off Campus Fee for early registration.
